Bill Adair, Jr. is a graduate of both The University of Alabama and The University of Alabama School of Law. He served in Walker County an Assistant District Attorney for two years and later as a Chief Deputy District Attorney for 14 years before being elected Walker County District Attorney in 2010. During his time with the District Attorney's Office Mr. Adair prosecuted multiple capital murder cases and the County's first DUI homicide case. Mr. Adair is an active member of the Alabama District Attorney's Association and has served as its vice-president and president. He has also served as president of the Walker County Bar Association. He served as a former member of the Walker County Fundraising Committee for United Way. Mr. Adair served as an adjunct professor at Walker College, which later became The University of Alabama at Birmingham and is now Beville State Community College. In addition to his other civic engagements, Mr.

Adair was the first Project Director for Daybreak, a local non-profit dedicated to serving victims of domestic violence, as well as a former president of its Board of Directors. He has also served on the board of directors of V.O.C.A.L., a statewide organization dedicated to establishing and protecting the rights of crime victims in the State of Alabama and

he is the founder and president of the Board of Directors for the Walker County Children's Advocacy Center. Additionally, Mr. Adair started the Deferred Prosecution Program in Walker County with an integrated citizens board for review of cases and taught Traffic Homicide for the Alabama State Trooper Academy. As a prosecutor, Mr. Adair has seen firsthand the victimization of our elderly citizens. In an effort not only to educate them, but also the public, law enforcement, care providers and family members Mr. Adair has worked in concert with M4A and the Walker County Chamber of Commerce in 2014 and again in 2016 to host Elder Protection Seminars. Not only were these seminars free to the public and provided much needed education and information to our elderly, but they also provided continuing education credits to all those medical, law enforcement and attorneys who participated.

Brandon Lackey served The Foundry Ministries for nearly two years as the Director of Changed Lives Christian Center, a homeless transitional housing ministry, before transitioning to his current role as Chief Program Officer in 2015. "In this position, my primary responsibility is to support the directors of our front-line ministries, so they can meet the mental, physical, social and spiritual needs of each of our program participants," he says.

Before joining The Foundry, Brandon served for more than a decade with one of America's oldest, largest and most successful Christ-centered recovery programs, Teen Challenge USA, where he held positions in direct services, communications and development. He holds a Bachelor of Science in the behavioral sciences from The University of Alabama at Birmingham and has been published by the National Academies of Sciences, Engineering and Medicine.

Advocacy for those without a voice is important to Brandon so he serves on the boards of the Alabama Rescue Services Association and the Alabama Association of Christian Recovery Ministries. As a founding member of the Alabama Association of Christian Recovery Ministries, he was instrumental in working with the Alabama Legislature to change Alabama's mental health laws protecting religious freedoms and choice in recovery. He also created a set of peer reviewed standards for non-medical recovery organizations that emphasize best practices, transparency and

accountability. He worked with the Alabama District Attorney's office to classify the addictive compounds found in Kratom as a Schedule I controlled substance and continues to work closely with state officials in a watchdog role to identify emerging threats to the public's health and safety. Most recently, Brandon has been named to Alabama Governor Kay Ivey's Commission on Opioid Abuse and Overdose with a focus on expanding access to treatment and recovery services.

Brandon has been married to Deidre, a nationally published photographer, since 2003 and has two children - soccer playing John Brooks and chess playing James.

## Attorney General Steve Marshall

Steve Marshall was sworn in as the forty-eighth attorney general of the state of Alabama on February 10, 2017.

Marshall received his undergraduate education at the University of North Carolina at Chapel Hill, and his legal education at the University of Alabama School of Law, graduating from both with academic honors.

Prior to taking office as attorney general, Marshall was the district attorney for Marshall County, a post he held for sixteen years. As district attorney, Marshall helped draft and pass the Brody Act—a law that makes it a homicide to kill an unborn child during an attack on the unborn child's mother. Marshall later became the first prosecutor to secure a death sentence under the Brody Act (in a case where a man murdered his pregnant wife and was charged with the homicide of both her and her unborn child). Five years later, when this landmark case was on appeal to the Alabama Supreme Court, Marshall—now attorney general—had the privilege of defending that conviction.

As attorney general, Marshall has embraced his role as the state's chief law-enforcement officer and has committed himself to making Alabama a safer place to live. In January 2018, Marshall launched the Initiative on Violent Crime with the mission to “help cities reclaim their streets, restore the rule of law, and . . . see their communities revived.” Since its launch, the initiative has resulted in the arrests of hundreds of violent offenders.

Marshall was recently elected to the executive committee of the Republican Attorneys General Association, a nod to his demonstrated expertise and leadership on a variety of national policy issues including the opioid crisis, illegal immigration, and religious liberty. Marshall is a man of deep faith with an impeccable reputation. He is known as a standout in law-enforcement circles. On the day of his swearing-in, nearly every district attorney in the state came to the capital to show their support for him. He and has one daughter, Faith, and attends Church of the Highlands in Montgomery, Alabama.
